### Road Warden scheme

- More information is available here
- A formal agreement between DCC and a Town or Parish Council
- Allows communities to organise and undertake works on or away from the live carriageway









### Why do we offer a Road Warden scheme

- People asked us if they could do it
- Size of the network
- Largely rural area
- Funding challenges







### Types of work that road wardens typically do

- Pothole repairs (when they do not meet our intervention criteria).
- Clearing weeds.
- Cleaning signs.
- Cleaning drainage (gully grating).
- Cutting grass.
- Repairing finger posts.
- Cutting hedges.
- Managing verges for wildlife







#### However, please note that:

- Hedges are generally the responsibility of the adjacent landowner
- We don't fund contractors to cut grass, we do assist with tools, materials, and training.







### Duties of a Road Warden

- Nominated as suitable by the town or parish council
- Communication link between DCC and the parish council
- Agree to work within the arrangements set forward by the Road Warden agreement
- Co-ordinate any minor works which are undertaken within the parish or town
- Ensure that <u>risk assessments</u> are undertaken and are easily accessible upon DCC request.



### Duties of a Snow Warden



- Ordering grit supplies
- Undertaking training and keeping a register of trained volunteers
- Receiving and responding to local weather alerts
- Organising and deploying volunteers to spread grit or clear snow
- Encouraging responsible use of grit and salt with community









### Duties of a Snow Warden Volunteer

- Spreading grit
- Clearing snow
- Refilling grit bins and bags
- Reporting issues with grit bins and bags

DCC will provide up to five tonnes of salt to participating parishes (with a Snow Warden and suitable place to store the material) free of charge







## Self-funded scheme delivery



- Details are in our committee report
- Aimed at delivery of minor highways improvements
  - Dropped crossings
  - Footways
  - Speed limits
  - Traffic calming features
  - Pedestrian crossings

- Volunteer strimming


#### Improvement Grant
